At that point in time this contract becomes binding. The fee schedule above applies to the 2010-2011 school year only.

All parents of children attending the school are members of the School Association until the child leaves the school. Tuition and Membership fees for a term are due upon enrolment or due date specified.

Pro-ration: The Annual Tuition Fee only is pro-rated for students who leave early or enrol late per the schedule below. Membership fees and enrolment fees are not pro-rated and are non-reimbursable once the 6 week probation period has passed.
